



# OFF LICENCE

SECTION 17 TO 20 AND 64, SALE AND SUPPLY OF ALCOHOL ACT 2012



29/OFF/053/22

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **Sandhu Brothers Limited** (the licensee) is authorised to sell alcohol on the premises situated at 406 Karamu Road North, Hastings and known as "Big Barrel Karamu", to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

## CONDITIONS

This licence is subject to the following conditions:

- a. **Alcohol may be sold only on the following days and during the following hours:  
Monday to Sunday 9.00 am to 10.00 pm**
- b. **No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.**
- c. **The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.**
- d. **Drinking water is to be freely available and free of charge to customers at the following area where free alcohol samples are being supplied: In each area where free alcohol samples are provided.**
- e. **The holder of this licence must display on the website, in a prominent place, the alcohol licence number, expiry date and a copy of the licence for the premises.**
- f. **The holder this licence must ensure that any alcohol sold by internet sale is not delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11.00 pm on any day or before 6.00 am on the next day.**
- g. **The whole premises is designated as: Supervised.**
- h. **The licensed area is described in a plan date stamped as received by the Hastings District Licensing Committee on 14 August 2019.**

## Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force:

- a) either:
  - (i) until the close of the period for which it was last renewed; *or*
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; *but*
- b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either:
  - (i) until the close of the period of 3 years after the period for which it was last renewed; *or*
  - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
